- Polybrominated biphenyls (PBB) < 0.1%
- Polybrominated diphenyl ether (PBDE) < 0.1%
- Bis(2-ethylhexyl) phthalate (DEHP) < 0.1%
- Butyl Benzyl phthalate (BBP) < 0.1%
- Dibutyl phthalate (DBP) < 0.1%
- Diisobutyl phthalate (DIBP) < 0.1%

Concerning all products none of these substances are used in the production.
